***Subject: — Raising the upper age limit for entry into Government Service.***

Sir,

I am directed to refer to Haryana Government letter No.3/3/99-1GSIII, dated 22.9.1999 on the subject noted above and to say that for the purpose of making recruitment to various services under the State Government, the general upper age limit prescribed at present under rule 3.6 of Punjab Civil Services Rules, Vol. 1, Part-I, is 40 years. Consequent upon raising the age of superannuation from 58 to 60 years of the Government Employees and 62 years in case of Group-D employees, it has been decided to raise the upper age limit for entry into Government Service from 40 years to 42 years for all categories.

- (a) The existing instructions in regard to the relaxation of 5 years in the upper age limit in respect of Scheduled Castes, Scheduled Tribes and Backward Classes for appointment to gazetted as well as non-gazetted services or posts will continue to be in force,
  - (b) The relaxation in upper age limit for recruitment in respect of ex-servicemen as contained in Haryana Government Circular letter No. 4710-5GS-70/18998, dated the 15th July, 1970, will continue as heretofore. In other words, the candidates of this Category may be recruited upto the age of 42 years plus continuous military service added by three years, and
  - (c) If in certain service rules, the upper age limit higher than 42 years is permissible on account of special grounds or in certain circumstances those provisions shall continue to remain in force.
2. It is requested that these instructions may be noted carefully for immediate compliance and amendment in the relevant service rules, wherever considered necessary, should also be made in accordance with the circumstances/conditions pertaining in each service under your control.
  3. This decision shall come into force with immediate effect and shall have prospective effect only.

These instructions should be brought to the notice of all concerned for being adhered to strictly.
