(made under Rule-17 and the Rule-19 of the Haryana Civil Services (Revised Pay), Rules, 2008)

No. 1/98/2013-2PR(FD) Dated, Chandigarh the 28th August, 2014

Subject: Regarding up-gradation of the functional Grade Pay of the Haryana Govt. employees.

\*\*\*\*\*

Whereas the pay scales of the State Government employees were revised w.e.f. 01-01-2006 vide Haryana Government Notification No. G.S.R.-44/Const./Art. 309/08, dated 30th December, 2008.

The matter has been further considered by the Government at length and it has been decided to further up-grade the pay structure of some categories of Haryana Government Employees. Accordingly, in exercise of the power vested under Rule-17 and Rule-19 of the Haryana Civil Services (Revised Pay) Rules, 2008 and all other powers enabling the Government so to do, the pay structure of Haryana Government employee is hereby revised/modified as under:-

- 1. Functional Pay structure of all the posts, carrying Pay Band-2, 9300-34800+3200 GP & 9300-34800+3300 GP as on 01-01-2006, is hereby upgraded to PB-2, 9300-34800+3600 GP w.e.f. 01.09.2014. However, this upgradation will not be applicable on those posts of which the Grade Pay was upgraded subsequent to revision of pay scale effective from 01-01-2006 (Illustration given below).
- 2. Functional Pay structure of all the posts, carrying Pay Band-2, 9300-34800+3600 GP as on 01-01-2006, is hereby up-graded to PB-2, 9300-34800+4000 GP w.e.f. 01.09.2014. However, this upgradation will not be applicable on those posts of which the Grade Pay was upgraded subsequent to revision of pay scale effective from 01-01-2006 (Illustration given below).

To illustrate, Grade Pay of following posts has further been upgraded subsequent to revision of pay scale effective from 01.01.2006, therefore, the benefit of this up-gradation will not be applicable on these and other similar posts:-
