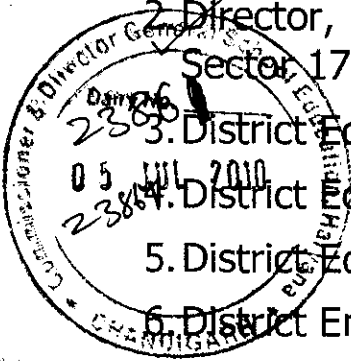

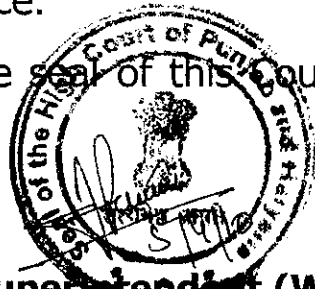

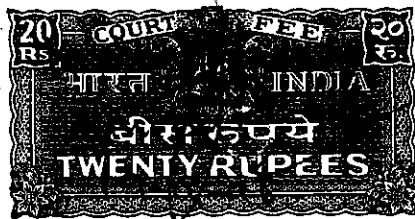

- (i) Issue a writ in the nature of Mandamus directing the respondent Nos. 6, 7 & 8 to register and to sponsor the names of the petitioners to the Respondent Nos. 3, 4 & 5



Policy of Haryana in view of the Govt. of India order with a further direction to treat the petitioners eligible for the post of Hindi Teachers and be interviewed to consider for the post of Hindi Teachers as per merit and not to discriminate them in this regard.
- (ii) Issue directions to Respondent No. 9 (SSS Board) to accept the application forms of the petitioners and to interview the petitioners and if found suitable on merit the petitioners be selected and appointed as Hindi Teachers in response to Board's Advt. (Annexure P.7).
- (iii) Issue any other appropriate writ, order or direction which this Hon'ble Court may deem fit and proper under the present circumstances of the case;
- (iv) to dispense with the filing of certified copies of Annexures P.1 to P.7.

- (v) to dispense with the issuance of advance notices upon the respondents.
- (vi) to award costs of the petition to the petitioners.

It is further respectfully prayed that during the pendency of the writ petition in this Hon'ble High Court, respondent Nos. 6, 7 & 8 be directed to register and to sponsor the names of the petitioners to the respondents Nos. 3, 4 & 5 for the post of Hindi Teachers and further be directed to interview the petitioners; provisionally and respondent No. 9 be directed to accept the application forms and to interview the petitioners for the posts of Hindi Teachers; as this Hon'ble High Court has granted interim relief in Civil Writ Petition No. 3113 of 1995 and to consider the petitioners' candidatures on merit in the interest of justice.

PERMOD KOHLI, J. (Oral):

The petitioners in these writ petitions after acquiring Matriculation qualification and Prabhakar from the M.D.U., Rohtak, also claims to have acquired Shiksha Vishard/Language Teacher Course from the Hindi Sahitya Sammelan, Allahabad. All the petitioners are duly registered with the various employment exchanges in their respective districts on the basis of their qualifications except Shiksha Vishard/Language Teacher. They claimed to have approached the employment exchanges concerned to register them on the basis of their additional qualification of Shiksha Vishard/Language Teacher which they had acquired from Hindi Sahitya Sammelan, Allahabad. However, their request has not been acceded to. The petitioners have, accordingly, filed these writ petitions seeking a direction for their registration in various employment exchanges impleaded as

respondents in the writ petitions and to consider them for selection and appointment for the post of Hindi Teacher with a further direction to the respondents to recognise the qualification of Shikha Vishard/Language Teacher course from the Hindi Sahitya Sammelan, Allahabad.

Mr. RKS Brar, learned Additional Advocate General, Haryana, appearing for the respondents has placed reliance on a Division Bench judgment of this Court in the case of Ram Bhagat Sharma Vs. State of Haryana, 1997 (4) SCT, 820, wherein the following observations have been made:-

“ The above narration shows that Hindi Sahitya Sammelan, Allahabad, and/or Hindi Sahitya Sammelan, Prayag, Allahabad, have neither been established under an Act of the Parliament or of the State Legislature nor have they been recognised by Kurukshetra University or Maharshi Dayanand University. The so-called examination centres being run in the State of Haryana appear to be bogus. As per the committee, they are being run in single room or in residences and the students are charged between Rs.1500/- and Rs.6000/-. These centres are not qualified for coaching

Shiksha Vishard students. They receive question papers etc. from Hindi Sahitya Sammelan, Prayag, Allahabad, but thereafter the centres are run independently and full sureties are given to the candidates to get through the examination by securing good marks. It can thus be said that the examinations conducted at these centres are totally farce and the degrees/diplomas/certificates etc. awarded by Hindi Sahitya Sammelan, Allahabad and/or Hindi Shitya Sammelan, Prayag, Allahabad, on the basis of such examinations cannot but be treated as bogus. On the basis of such degrees etc., the petitioners or any other candidate cannot claim eligibility for the purpose of appointment of Hindi Teacher."

In view of the above, it appears that these qualifications acquired by the petitioners are not recognised by law and declared as bogus qualification by the Court. Hence, no relief can be granted to the petitioners.

Petitions dismissed with no order as to costs.

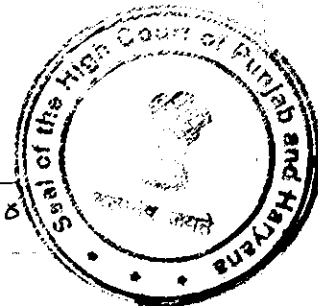
